II. THE EVIDENCE

Proof of Sight

A precise chronicle proving your capacity to act as a “Seer” — one concrete historical example of an invisible threat you predicted, or a hidden market opportunity you captured ahead of time.

III. THE SOVEREIGN PROPOSAL

The Terms

State your price. Dictate your precise economic, spatial, and social terms. Tell us exactly what compensation, equity, and sovereign freedom the execution of your genius requires to activate your terminal.

This document, in full, constitutes the operative terms referenced in the Acknowledgment of Terms on the final page. By signing that page, the undersigned confirms having read and understood the Alliance Manifesto and the Chronicle of Intent requirement in their entirety, as presented above.
